I have been an Anglican since birth, growing up in Sydney. After school, I spent most of the next 20 years in Canberra-Goulburn Diocese, except for four years overseas studying for a Masters in Christian Studies at Regent College (Vancouver) and a PhD at Vrije Universiteit (Amsterdam), in Biblical Hebrew linguistics. I was ordained to the priesthood in 2009 and in 2010 moved to Adelaide to be Principal of St Barnabas Theological College (2010-2017). I was delighted to be commissioned as Priest in Charge at St Theodore's, Toorak Gardens, in September 2022.

I have always loved parish ministry and academic scholarship, and I remain active in both areas. In ministry, I enjoy preaching and pastoral work. I have presented Bible Studies at the National Anglican Deacons Conference; the National Anglican Bishops Conference; the Willochra and Adelaide Synods; the Willochra, Adelaide, Ballarat, and Canberra-Goulburn Clergy Conferences; General Synod; and the National Anglican Deans Conference.

I have represented the Diocese of Adelaide at General Synod since 2017 and am actively engaged with Anglicans from around the country in the promotion of an inclusive, comprehensive, and open-hearted Anglicanism.

I have been on the Doctrine Commission for the Anglican Church of Australia since 2014, contributing three chapters to our book, *Marriage, Same-sex Marriage and the Anglican Church of Australia: Essays from the Doctrine Commission, 2019*: "Scripture and Moral Reasoning", "An Alternative Reading of the BCP", and "The Case for Same-Sex Marriage". I also submitted a substantial paper to the Appellate Tribunal Wangaratta Referral (2020).

These publications, and my advocacy in the media and elsewhere as a straight ally for LGBTIQA+ Anglicans, are also integral to my vocation as a priest and scholar.

In academia, I am an honorary research fellow/doctoral supervisor at the University of Sydney, University of Queensland, University of Adelaide, and Charles Sturt University. I founded and co-chair the Biblical Hebrew Language and Linguistics Unit, Society of Biblical Literature (International), and am a member of the Linguistics and Biblical Hebrew Unit, Society of Biblical Literature, and the National Association of Professors of Hebrew (USA). I am also a trustee of the Australian Research Theological Foundation Incorporated (ARTFinc).

My major research area currently is the Psalms. Under the auspices of the Liturgy Commission of the ACA, I am preparing a new translation of the Psalms for public worship. I am grateful for this opportunity to translate, study, and reflect deeply upon the Psalms, as it draws together both my pastoral and scholarly vocations.

I have been involved in a wide range of ministries within the Diocese of Adelaide and beyond. I am currently the Rector of the Parish of Christ Church North Adelaide having commenced in the parish at the beginning of 2021. With ministry as a Parish Priest, Hospital and School Chaplaincy I am nominate with a variety of experiences and insights.

I have been in Ordained ministry since 2008, being ordained then at the age of 24. I am personally interested in seeing the Anglican Church empower all the baptised to live out their calling as followers of Jesus. It is the churches role to encourage and equip God's people to share the Good news about Jesus.

I have grown and been formed in the Diocese of Adelaide, having attended school at St. Andrew's Walkerville and then Pulteney Grammar School. Growing up in the Parish of St. Matthew's Kensington.

I commenced theological training at St Barnabas College in 2004. Graduating with a Bachelor of Theology. I have since completed in 2018 Master of Arts (Christian Leadership) through the Sydney College of Divinity including being part of the Arrow Emerging leaders program.

I have had involvement in the Parish of St. Mary Magdalene's, St. George's Magill, St. Peter's Glenelg, St. Peter's Cathedral, St. Martin's Campbelltown. I served a curacy at St. Peter's Glenelg before moving to the Diocese of Newcastle where I was the Rector of Bateau Bay Parish. While in Newcastle Diocese I was both a Spiritual Director and Spiritual Advisor to the Cursillo Movement in that Diocese. I was also the chaplain at Long Jetty Hospital.

Since returning to the Diocese of Adelaide, I have held ministry roles in Salisbury, Parafield Gardens, Lyell McEwin Hospital, St. Columba's Hawthorn and Walford Anglican School for Girls

My breath of church experiences range from the Book of Common Prayer at Christ Church North Adelaide, all the way through to Fresh Expressions of church in other parish. While in the Diocese of Newcastle I was involved in introducing the Fresh Expression of Church called Messy Church to the Diocese. At Bateau Bay parish we saw over 100 people each month come to find out about the Christian faith a model that was copied at several other parishes with similar success.

I have previously been a committee member of the Salisbury Business Association (2017-2019), a Member of BCA- SA/NT Regional Committee (2015-2016) a Mission support – Member of CMS-SA/NT (incorporating SAMS) and General Committee (2006 – 2009) Candidates Selection Committee (interviewed and recommended to General Committee – candidates for overseas missionary service). And within the diocese a was a member of the Mission and Evangelism Ministry Unit—Diocese of Adelaide 2015-2016





Grant Chapman is married to Sally, has a married son, three young grandsons and a single daughter. He has worshipped at St Matthew's Anglican Church, Kensington, S.A., since 1981 and served on its Parish Council in the mid-1980s. He served on Grace Anglican Network Council from 2017 until the Network's dissolution in January 2022 and continues on St Matthew's Parish Council, of which he is Chairman. He has been St Matthew's People's Warden and Select Vestry Member since 2020 and chaired the Rector Selection Committee, 2020 – 2021. He has served on the Adelaide Anglican Diocese Synod since 2016, also being Synod Chairman of Committees. He has served on the Board of Anglicare SA, 2015 to 2022.

Grant was a Member of the last Anglican General Synod, which met on the Gold Coast in May 2022.

He served on the Board of Bible Society, South Australia, from 2004 until it was subsumed by the national Bible Society Australia entity in 2011. He is President of Christian Faith and Freedom, which advocates on behalf of persecuted Christians around the world.

Grant won the marginal Federal House of Representatives electorate of Kingston three times for the Liberal Party, 1975 to 1983. Prior to 1975, he was a marketing executive with Shell Company of Australia Limited and from 1983 to 1987, a self-employed management consultant. From 1987 to 2008 he was a Liberal Senator for South Australia and Chaired the Joint Parliamentary Statutory Committee on Corporations and Financial Services, 1996 to 2007, overseeing A.S.I.C. and working closely with the then Federal Treasurer, Hon. Peter Costello MP, in reforming Australia's corporations law and the regulation of financial services.. He was Honorary Secretary of the Federal Parliamentary Christian Fellowship for a number of years.

In 2001, Grant was appointed by the United Nations to its "Panel of Eminent Persons to Combat Desertification," enhancing links with international business and political leaders which he developed as the leader of a number of key Australian overseas delegations and as the Australian Government representative on the Inter-Parliamentary Union (world body of parliaments) Council from 2000 to 2005. In 2003, the President of Chile bestowed on him the highest honour awarded foreigners, the Grand Cross, Orden Bernardo O'Higgins, for his contribution to international relations.

Since 2008 he has undertaken periodic business consulting assignments, served as a Director of several small business start-ups, overseen family farming property and since 2018, been a Part-time Senior Member of the Commonwealth Government Administrative Appeals Tribunal. He is President of the Kensington District Cricket Club and was President of the Liberal Party (SA Division) and a member of its Federal Executive, 2010 to 2013.

He holds an Honours Bachelor of Arts to degree from the University of Adelaide, an Entrepreneurship Certificate from the former S.A. Institute of Technology (now University of S.A.), is a Graduate of the Australian Institute of Company Directors and a Knight of the Order of St John of Jerusalem, Hospitallers.





ROB CROSER has been a constant parishioner at St Peter's Church, Glenelg since 1971. At various times, over those 51 years, he has served as a parish councillor, priest's warden, lay administrator, parish visitor and (for 18 years) synod representative. Within the wider diocese, he was also a member of the Diocesan Response Group (charged with investigating allegations of abuse and misconduct), a Lay Canon and member of the Cathedral Chapter.

By profession, he is a lawyer (now retired), having been admitted to the Bar in 1972. All his professional life was spent in the employment of the Australian Legal Aid Office, which then became the Legal Services Commission of SA. The final 35 years of his professional life were spent at the Adelaide Children's (and then Youth) Court, representing and advocating for thousands of abused and neglected children in Child Protection Proceedings.

Since 2020, Rob has been sitting as a part-time member of the South Australian Civil and Administration Tribunal, hearing cases involving guardianship and administration orders for people with diminished capacity; community mental health orders; and hearings reviewing decisions by the state welfare department affecting children and their carers.

I have belonged to the St Peter's Cathedral community since 2005. Previous parishes have included: St Oswald's Parkside, Church of Emmanuel - Wayville. I grew up at St Hugh's, Angaston as my family parish.

Having served as the cathedral's People's Warden (2017-2020), my current roles are: cathedral council, Dean's nomination committee, Synod representative; and within the diocese, Bishop's nomination committee, observer at Willochra Synod, St Barnabas college council. I am also a Director of AnglicareSA, and Chair the Advancement and Philanthropy committee.

The past eco-spirituality treks in the Willochra diocese played a pivotal part in my adult spirituality, as did the Wayville community (ex FUSA chaplaincy), and as do current clubfoot projects, and AnglicareSA roles.

I have a multi-path career as an academic (PhD conferred 2005) at La Trobe University and University of Barcelona, an Adelaide based clinician, and a Director of the Australian Podiatry Association. I continue to lecture globally, and academic publications include a textbook, multiple book chapters, many peer-reviewed journal articles, and a monograph series.

From 2005, I volunteered with Red Cross clubfoot projects in Vietnam. Since 2008 this transferred to a non-government aid project in Bangladesh, called 'Walk for Life Clubfoot', which has now treated over 30,000 children with congenital clubfoot deformity. Currently I am teaching across 30 countries as part of the Global Clubfoot Initiative, Oxford.

Wider volunteer history includes: National Medical Education Scientific Council and Medical Education Scientific Advisory Council of Diabetes Australia; Scientific Committees for National conferences, Medical programs at Sydney 2000 Olympic Games; World Winter Games Special Olympics, 2005; 2006 Melbourne Commonwealth Games; Clinical Director of National Games – Special Olympics, 2010.

In 2016 I received the British Medical Journal South Asia Healthcare Award for Excellence in Delivery of Primary Care for 'Walk for Life Clubfoot', and in 2019 became a Member of the Order of Australia. A key interest is the nexus between research and clinical practice, and the urgent need for environmental sustainability in healthcare.

I undertook leadership training at LH Martin, the University of Queensland Business School, and in the Flinders Vice Chancellor's Management and Leadership Program. At the same time (among other things) I was a member of several scholarly organisations, President of the International Water History Association, SACE Board Chief Assessor for History, and lecturer at UNESCO IHE, Delft.

Unsurprisingly, my experience built in me a fascination with how institutions form, change and perpetuate themselves - a fascination that inspires my academic research. I am currently working on the dynamics of military and industrial mobilization for war and their impacts on large institutions such as the Australian Army and various arms of the Australian government.

Dr Carol Irizarry retired in 2019 from Flinders University where she was the Dean (Education) of the College of Education, Psychology and Social Work. She currently has Full Academic status as Associate Professor in the College of Education, Psychology and Social Work.

Carol completed her MS (Social Work) at Columbia University in New York City and worked in Canada as social worker and administrator in the health sector. Her role involved extensive work supporting refugees from Latin America as well as migrants from Portugal and the Cape Verde islands. Carol completed her PhD at Rutgers University in New Jersey on children's reactions to the death of a grandparent – a study that was conducted with school children in Adelaide after she had taken a position in the School of Social Work at Flinders University.

During her years at Flinders University, Carol acted as Head of Social Work for over a decade during which time she established a Graduate Certificate in Loss, Grief and Trauma which was attractive to clergy in South Australia and broader afield by distance education. The last two years at Flinders Carol hold the role of Dean (Education) as the new College of Education, Psychology and Social Work was established and was responsible for all the academic offerings across the College for 5000 students. 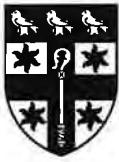
Dr David Phillips, BSc, MSc, PhD, ThA, MAIP had a professional career as a research scientist with the Commonwealth Government.
